# Strategic relations are based on common values

This year started optimistically with the resumption of flights and lifting of travel restrictions for European and Indian citizens imposed due to the pandemic. These measures will facilitate the movement of entrepreneurs and their products, which is necessary for the further development of international trade and economic relations. Overall, the economy is rebounding strongly, Greece's GDP growth in 2021 stood at 8,5 percent, one of the highest among the EU members. Growth is expected to be 4,9 percent in 2022, with the unemployment rate already descending to the pre-pandemic levels. The significant improvement of the economic indicators in the bilateral economic relations between Greece and India makes us even more optimistic. In 2021 a significant increase of 74,6% of Greece's exports to India was recorded, which amounted to € 134,3 million from € 76,9 million the previous year. Imports from India increased and amounted to € 699.2 million from € 415,1 million, also marking a significant increase of 68,4%, with the result that the volume of bilateral trade increased by 69,4%, amounting to € 833 million, setting a record for the last five years.

Today, 75 years after declaring its independence, India is emerging as a global power and is projected to soon become the most populous country in the world with one in 6 people on the planet being Indian, India is a G20 member worth € 3 trillion and a leading actor in the Indo-Pacific, home to nearly two-thirds of the world economy.

However, with the escalation of the geopolitical situation due to the Russia – Ukraine war, the global whirlwinds of high inflation, the supply disruptions of goods and food products, and the energy crisis, the



future of global economic growth is uncertain. More than 23 years after the end of the war in Yugoslavia and 48 years after Turkey's invasion of Cyprus, Europe is facing again a military conflict, with a danger to turn into a global catastrophe. Governments must seek a peaceful settlement rather than a military and economic confrontation.

In this challenging context,
Greece and the EU are seeking to
develop strategic ties with India. This
intention is also supported by India.
The political ties between Greece and
India are now stronger than ever,
after three meetings over the last
months, between the Foreign Ministers of Greece and India in Athens,
Paris, and New Delhi, which were
followed by the official visits of the
President of the EU to India and the
visit of the Indian PM in Europe.

Greece and India are two pillars of the world civilization on which the cultures of the West and the East have been based. Therefore, they have a historical duty to once again play a leading role in promoting world peace and the spiritual well-being of humanity. The oldest democracy Greece and the largest democracy India can rely on each other as cultural and strategic part-

ners giving by example directions to the rest of the world.

One such example was set by India when it expressed its global solidarity by sending millions of free vaccines from its initially limited production to less economically developed countries. And when the situation worsened for India, the European Union, including Greece, in its turn sent medical aid to the country in need.

The uncovering of the statue of Mahatma Gandhi in Athens and the painting exhibition in New Delhi last year dedicated to 200 years since the Greek Revolution are two important steps in the strengthening of Greek-Indian friendly and economic relations through a better historical and cultural understanding.

High-ranking decision-makers from the areas of business, politics, education, and culture should join hands in creating an environment in which economic growth and material prosperity can walk side by side with the values that nurtured international law and human values. Only then strategic relations between the West and the East, Europe and India, will become truly feasible.

Message by **Deputy Minister of Foreign Affairs** for Economic Diplomacy and Openness

Throughout the years, bilateral relations between Greece and India stand at an excellent level, based on the shared common values of democracy, freedom and the rule of law. Our bilateral relations are marked by rich civilization linkages and currently there is also a new impetus to the economic relations between our two countries.

This was confirmed during the recent 8<sup>th</sup> session

of the Greek- Indian Joint Economic Committee, on April 15, 2022. What we have agreed upon is to further enhance our economic and commercial relations, to encourage exchanges, explore opportunities and

facilitate cooperation with particular emphasis on economy and trade, energy - especially renewable energy resources - but also maritime transport, defense, and culture.

India's successful participation in Thessaloniki International Fair/HELEXPO 2019 as the honored country was a milestone towards further reinforcement of our bilateral economic and trade relations.

Our bilateral trade recorded significant growth in 2021, reaching a peak of €833,4 million. However, there is still ample room for improvement. The

Memorandum of Understanding signed recently between Enterprise Greece and Invest in India - the respective Greek and Indian official investment and trade promotion agencies – is expected to function as a tool for the strengthening and expansion of the business ties among Greek and Indian entities, as well as for the encouragement of the bilateral foreign direct investment (FDI) flows.

Our government's stated policy is to make Greece the focus of attention for investors across the world. Greece's development law aims at attracting foreign investments by creating a friend-lier and more func-

tional investment environment. We welcome Indian companies wishing to invest in Greece to profit from these opportunities.

We also encourage the exchange of targeted business delegations between our countries, organized by Business Associations and Chambers of Commerce (Hellenic-Indian Chamber of Commerce and Economy), as well as the increase of Indian businesses' participation in trade and investment exhibitions in Greece.

I am confident that the Air Services Agreement

ratified by the Greek Parliament last February, will significantly contribute to the commencement of direct flights between several points in both countries, and further develop our bilateral touristic, cultural, commercial and economic relations.

Greece and India also share a common objective of promoting Renewable Energy Sources, since they both dispose significant solar and wind potential. Furthermore, hydrogen, offshore wind, energy storage and energy efficiency are fields of common interest. The signing and recent ratification by the Greek Parliament of the Framework Agreement for the Establishment of the International Solar Alliance (ISA) as well as the MoU on Cooperation in the Field of New and Renewable Energy, constitute significant steps towards the implementation of synergies in the field of RES.

There are also significant prospects for the deepening of economic and commercial cooperation between Greece and India, in the fields of high technology and tourism. Cooperation of research organizations from both India and Greece in the fields noted above; presents a great potential. Furthermore, the elaboration of joint research personnel exchange programs, joint research projects and capacity-building programs are promising areas of cooperation.

Tourism plays a significant role in terms of promoting and reinforcing our economic cooperation, being at the forefront of our economies and having an important contribution to our GDPs. And it is true that we have made great steps forward in the field through the participation of the Greek National

Tourism Organization at the International Tourism Exhibition "Outbound Travel Mart" from 2017 to 2020, as well as through the participation of India at the 84<sup>th</sup> International Exhibition of Thessaloniki in 2019 as the honored country.

Aiming at exploring new fields of cooperation, Greece and India are ready to work together in the field of film and audiovisual production. In this context, Greece proposes the cooperation between the competent Greek and Indian authorities on promoting the cinematography of both countries, exchanging of expertise and supporting Greek and Indian professionals who choose India and Greece as a production location for their film or TV series.

In closing, I would also like to congratulate India on the resilience and performance of its economy which not only managed to grow faster than any major economy last year, but also swiftly reached the pre-Covid levels, while keeping diversifying with an eye on the future. With the Greek economy having overcome a challenging decade of crisis, followed by the global financial crisis caused by the Covid-19 pandemic. I am confident that the strategic and friendly relations between our two countries, along with our mutual desire to strengthen and develop our economic cooperation, shall lead to a prosperous future of collaboration and mutually beneficial prospects. •

# Unveiling of the statue of Mahatma Gandhi in Athens

The unveiling of the statue of Mahatma Gandhi was held on Saturday, June 26, 2021, by the Ministers of External Affairs of Greece and India Mr. N. Dendias and Dr. S. Jaishankar in a special event organized by the Mayor of Athens Mr. Kostas Bakoyannis in front of the Embassy of India in Athens.

In their addresses at the event, the Mayor and the Ministers expressed their belief that the new statue would act as a strong symbol of friendship and common values between Greece and India, Foreign Minister Nikos Dendias paid tribute to Gandhi's legacy for his country and humanity as a whole, stressing that Greece and India honor his memory by working towards promoting global peace and stability.

In the unveiling ceremony, which due to the pandemic was attended by a few guests, present were the Ambassador of India to Greece Mr. Amrit Lugun, the Chairman of the Greece-India Parliamentary Friendship Group and former Prime Minister Mr. George Papandreou, the chairman of ELINEPA and GIBA Dr. Dimitrios Vassiliadis, ambassadors and diplomats from Greece and other countries and representatives of the press and Greek-Indian cultural and business organizations.

The base of the statue has the phrase of Mahatma Gandhi "THERE IS NO WAY TO PEACE, PEACE IS THE WAY" which characterizes his

predominant belief in non-violence (ahimsa).

The statue of the Father of India in the city of Socrates, whom Mahatma Gandhi admired and characterized as "perfect Satyagrahi" and translated the *Apology of Socrates* for the first time into an Indian language, will act as a strong symbol of friendship between the two countries. •

India and Greece enjoy time-trusted relations since historical past, having old and traditional long-standing ties, and both are thriving democracies. Both countries have very good and strong diplomatic relations since the Independence of India (Greece established its Diplomatic Mission in India in 1950, while India opened its Diplomatic Mission in Athens in 1978). India and Greece, both are consistently supporting each other's foreign policy objectives at various international levels. These ties are strengthened by frequent high-level visits including those of Hon'ble Presidents of India to Greece in 2007 and 2018, and of the President of Greece to India in 1982.

In 2021 at the invitation of the Minister of Foreign Affairs of the Hellenic Republic, Mr. Nikos Dendias, the Minister of External Affairs of India, Dr. S. Jaishankar, paid an official visit to Greece on 25-27 June. On the occasion of the 200th anniversary of Greek independence, the External Affairs Minister conveyed felicitations of the President and the Prime Minister of India to the Government and the people of Greece. During the visit the External Affairs Minister paid a courtesy call on H.E. Mr. Kyriakos Mitsotakis, Prime Minister of Greece, and had talks with his counterpart, Mr. Nikos Dendias. He also unveiled the statue of Mahatma Gandhi in Athens. Both sides shared views on regional and global issues of mutual interest in the context of new geopolitical and geo-economic realities, including the Indo-Pacific, Eastern Mediterranean, Cyprus, and Libya. They stressed the need to enhance bilateral ties in many spheres, including the fields of trade and commerce. Greece formally joined the International Solar Alliance.

In 2022 Greek Foreign Minister Mr. Nikos Dendias paid an official visit to India on 22-23 March. During his visit, both sides discussed and explored ways to further strengthen the close and friendly ties between the two countries. They pointed out that trade has shown a significant increase, despite the challenges posed by the pandemic. Both sides agreed to work together to further enhance collaboration in mutually beneficial sectors such as shipping & maritime, information technology, agriculture, new & renewable energy, and pharmaceuticals. During the visit the Declaration of Intent on Migration and Mobility was signed. A Cultural and Education Exchange Programme for the fiveyear period 2022-2026 was signed during the visit. The Greek Foreign Minister handed over the Instrument of Ratification of Greece as a signatory to the Framework Agreement on International Solar Alliance. Both sides discussed the possibility of enhancement of bilateral relations to a Strategic Partnership. During his visit, the Greek Foreign Minister called on Hon'ble Vice President Mr. M. Venkaiah Naidu and delivered a speech at the Jawaharlal Nehru University in Delhi where he announced the reinforcement of the Chair of Greek Studies with a visiting professor from Greece.

# Official visit of the Union Minister of State for Commerce and Industry Smt. Anupriya S. Patel to Greece

Union Minister of State for Commerce and Industry Smt. Anupriya Singh Patel arrived in Athens on April 14, 2022 to co-chair the 8<sup>th</sup> meeting of the Joint Economic Committee (JEC) and to have a series of meetings with Greek politicians and members of the Indian diaspora.

The Session's agenda included the strengthening of bilateral trade of goods and services, cooperation in the field of renewable energy, improvement of air and maritime links, as well as the enhancement of cooperation in the tourist sector.

Earlier, the Indian MoS met with the Minister of Rural Development and Food, Mr. Georgios Georgantas. The subject of the discussion, which took place in a friendly atmosphere, was cooperation between the two countries, mainly in the matters of trade in agricultural products and exchange of knowhow.

Both sides shared their positive approach towards cooperation in agriculture and hope that the MoU on agriculture would be signed soon, which would open up multiple areas of cooperation.

Smt. Patel also met with Deputy Minister of De-

velopment & Investment Mr. Christos Dimas. The focus of their contacts was the deepening of cooperation in science, research & innovation, agricultural economy, RES, tourism, etc.

During her visit to Athens, the Indian MoS held a number of meetings with members of the Indian community living and working in Greece and offered flowers in memory of Baba Saheb Ambedkar at a special event organized by the Indian Embassy on the occasion of the 131st anniversary of his birth.

She also visited the Benaki Phytopathological Institute (established in 1929) to explore cooperation between the institute and Indian counterparts.

In honor of the Indian Minister, the Embassy of India in Athens organized a reception at a central hotel in Athens which was attended by Deputy Minister for Foreign Affairs Mr. Konstantinos Fragkogiannis and members of the Business and Economic community of the country, ELINEPA was represented by its General Secretary Mr. Antonis Papadopoulos and the Greek-Indian Business Association (GIBA) by Director of Public Relations Mr. James Mimikos.

8th Session of India - Greece Joint Economic Committee (JEC)

The 8<sup>th</sup> Session of the Greece-India Joint Economic Committee, concluded its work on April 15, 2022, in Athens with the signing of the Protocol by the Deputy Minister of Foreign Affairs for Economic Diplomacy and Openness Mr. Kostas Fragkogiannis and the Minister of State for Commerce and Industry of India Smt. Anupriya Patel.

In their introductory remarks, the Deputy Ministers referred to the excellent level of relations between the two countries, noting the prospects for further strengthening and expanding economic relations in the fields of trade and investment, energy and renewable sources, transport and tourism.

The Greek delegation consisted of the Secretaries-General of the Ministry of Education and Religious Affairs, Mr. Apostolos Dimitropoulos, the Ministry of Rural Development and Food Mr. Konstantinos Baginetas and the Ministry of Tourism Ms. Olympia Anastassopoulou, high-ranking officials from the Ministries of Development and Investment, Infrastructure, Transport and Networks, Health as well as executives of Enterprise Greece, the Civil Protection Authority, Athens Chamber of Commerce & Industry and the Hellenic Cinema Center.

Discussions on a wide-range of issues in the economic, commercial and related areas such as agri-

culture, research & innovation, tourism, air services, maritime affairs, investment, energy, education, health & pharmaceuticals, etc. were held. The Committee also examined possibilities of enhancing trade in goods, in particular food, pharmaceuticals and construction materials.

The prospects of direct air connections between Greece and India were discussed as well, following the recent ratification by the Greek Parliament, in February 2022, of the Greece-India air connection agreement signed in 2017.

Upon conclusion of the Committee's work, Mr. Fragkogiannis praised the warm and constructive atmosphere of the talks, which, as he pointed out in a short statement to the Greek National Television (ERT), "prepared the ground for the next big business mission to India scheduled for the coming autumn".

This was the Committee's 8<sup>th</sup> Session – the previous one was held in New Delhi in 2016 – which confirms the momentum that has been created for the enhancement of economic and trade relations between the two countries, following the recent visit of the Minister of Foreign Affairs Nikos Dendias in New Delhi in March 2022. •

### Padma Shri Award conferred to Greek Indologist Prof. Nicholas Kazanas

A conferment ceremony was organized on March 1, 2022, in Athens to present the Padma Shri Award to the Greek Indologist Prof. Nicholas Kazanas for his distinguished service and contribution to the enrichment of literature and education.

The Ambassador of India to Greece Mr. Amrit Lugun presented to Professor Nikolas Kazanas the Padma Shri Award conferred by H.E. the President of the Republic of India in 2021 and spoke about its importance as it is India's 3<sup>rd</sup> highest distinction.

Chief Guest H.E. Mrs. Lina G. Mendoni, Minister of Culture & Sports of the Hellenic Republic, presented the Padma Shri medallion to Prof. Kazanas. In her speech, she stressed the importance of cultural contacts that unite Greece and India for millennia and expressed her wish for their further expansion.

Prof. Nikolaos Kazanas, in his speech, thanked the Government of India and the Honorable President for the honor bestowed on him, expressed his joy at receiving this Award and spoke about the philosophical and poetic significance of the Sanskrit language.

The ceremony was attended by several foreign and Greek diplomats, Greek Indologists, representatives of Greek-Indian Cultural Associations and prominent members of the Indian community residing in Greece.

Nicholas Kazanas was born on the Greek island Chios in 1939. He studied English Literature at University College, Economics and Philosophy at the School of Economic Science and Sanskrit at the School of Oriental and African studies – all in London; post-graduate at SOAS and at Deccan College in Pune, (India).

Since 1997 he has turned towards the Vedic Tradition of India and its place in the wider Indo-European culture. This research comprises a thorough examination of Indo-European cultures, comparing their philosophical ideas and values, their languages, mythological issues, and religions. He has also translated the ten principal Upanishads from the original Sanskrit text into Greek and authored several books and articles on Vedic and other philosophical and religious issues. •

### **Greece-India Bilateral Trade Relations**

The figures from the Hellenic Statistical Authority (ELSTAT) indicate that the trade balance is consistently in deficit to the detriment of Greece. In 2021, a deficit of  $\in$  564,8 million was recorded as Greek exports amounted to  $\in$  134,2 million, recording a significant increase of 74,6% compared to 2020, while imports to  $\in$  699,1 million, recording an increase of 68,4% compared to 2020. The deficit increased by 67% compared to the corresponding of 2020.





# **EU-India: Trade in goods statistics**


By the end of 2021, both exports and imports between the EU and India have been recovered after the sharp fall caused by the Covid-19 crisis in 2020.



In 2021, India was the tenth largest partner for EU exports of goods (€ 42 billion, 1,9 %) and also the tenth largest partner for EU imports of goods (€ 46 billion, 2,2 %). Among EU Member States, Germany was both the largest importer of goods from and the largest exporter of goods to India in 2021. The position of India among the largest trade partners of the EU in 2021 can be seen in the Figure below.



Both exports to and imports from India increased between 2011 and 2021. 2011 imports increased from 33,1 billion to 46,2 billion and exports increased from 34,6 billion to 41,9 billion in 2021.



# Doing Business with Greece is India's strategic priority

It is a well-accepted fact that Greece has geographically and historically been India's gateway to Europe. I must appreciate the relations we have enjoyed with GIBA and its business members, as well as the substantive support received by the Greek Embassy in India. Greece and India have much in common. We are modern nation-states built on the foundations of ancient civilizations. "Vasudhaiva Kutumbakam" is a timeless Sanskrit phrase that translates to "The World is a Family". It has guided India's external outlook down the ages and continues to do so. As sister civilizations from the earliest days of human society, Greece and India are special members of this family.

Our bilateral political and economic relationship goes back 2,500 years. Greece was the fountainhead of western culture and its imprint extended across continents. In India, too, there is an enormous evidence of Greek travelers, traders, scholars, and warriors interacting with our ancestors. The most famous Greek to come to India was, of course, Alexander the Great. He arrived at the head of an invading army in 326 BC - but he left as a friend. Every Indian schoolchild knows how Alexander and the Indian King Porus fought a pitched battle and then, impressed by each other's courage and dignity, became allies.

Shortly afterwards, Emperor Chandragupta founded the first great Indian empire, the "Mauryan Empire", which covered much of the Indian subcontinent. Chandragupta, who was known to Greeks of the time as Sandrocottos, was helped in his mission by Seleucus Nicator. Seleucus was Alexander's general and founded his own Greek empire in Asia.

It is believed that Chandragupta married Helen, the daughter of Seleucus and she became his queen. Seleucus sent Megasthenes to Chandragupta's court as, perhaps, the first Greek ambassador to India. Fortunately for us, besides being a diplomat, Megasthenes was a scholar, historian, and ethnographer. His travelogue "Indica" remains one of the best-known accounts of ancient India.

A fusion of Greek and Indian cultural influences gave rise to what is termed "Greco-Buddhist art" and to the "Gandhara School of art and sculpture". The Greek geographer Ptolemy mapped the seven islands that today make up the city of Mumbai. He called this collection of islands "Heptanesia", which is the Greek term for "seven islands". More recently, in 18th and 19th century India, there was a flourishing community of Greek businessmen, and traders in spices, jute, and other commodities. The Greek Orthodox Church in Kolkata still stands proudly with its impressive Doric columns.

I have given you only a few examples of the exchanges between Greece and India since antiquity. There are, of course, several more. Yet, to my mind, the most important attribute we share is a commonality in values. Athens, is regarded as the "cradle of democracy". In ancient India, too, there was a tradition of "city-repub-

lics", such as the "Licchavi republic" in the modern state of Bihar. The values of liberal democracy, public sovereignty and transparent government continue to guide us and are cornerstones of India's relations with Greece and with the European Union. Ours is a partnership of principles. It is much more than a transaction. It is a friendship tested by time, by cherished beliefs – and by sacrifice.

Like you, we recognise and believe that the "age of empires" is over. The 21<sup>st</sup> century will be built by democracies, such as ours – democracies that place a premium and a priority on the wellbeing of citizens; on jobs and opportunities for local communities, and on a global development model that is economically viable, ecologically sustainable and ethical in its architecture.

This is the perfect time for India and Greece to increase bilateral cooperation. Greece could also procure defence systems from India and I am optimistic about the possibility of India and Greece jointly developing their co-operation in strategic research and innovation.

The possibility of a strategic partnership between India and Greece is not new and goes back to 2011 when Greece and India agreed to cooperate on combating terrorism and countering pirates in the Indian Ocean and we must prioritise bilateral relations from a security point of view as well.






### Meeting with the President of the Poland-India Business Council



### Greek-Indian Trade Revised

The Indo-Greek relations have a long history. They are much beyond comprehension, as scholars and laypeople are so much bogged down in the history of the last two centuries of British colonial presence. To start with, the Indo-Greek relation, it was not a colonial or imperial one – a large exception is the expedition of Alexander the Great but one has to understand that he was primarily a Macedonian adventurer. The Greeks touched the deep cores of ancient India, particularly the Buddhist regimes and Buddhist discourse. Thus the great ancient culture of Greece which gave the civilizational input to the European culture and life had an equal share in creating bonds with Buddhist India and the discourse on culture and philosophy. It was natural that the two most thinking civilizations reached a relationship that encompasses philosophy and arts and they left their impact on the rest of the world. Greek thought influenced the whole of Europe to graduate into a rational and reasonable society. Similarly, Ancient India influenced East Asian territories which are known nowadays as the Indo-Chinese countries of Thailand, Indonesia, Laos Cambodia, and beyond. Buddhism spread even further. It crossed the Indian ocean and Himalayan heights and went to central Asia, crossed into China, and then went up to the farthest East, to Japan.

There is a need today to build up freshly this relationship in the context of the modern world's evolution as it is taking place and trade and commerce play a big role. India since its decolonization has been emerging as an important player in world affairs and currently tops the list of fastest-growing economies.

It must be emphasized that trade and commerce on a global level and particularly in the case of Indo-Greek relations need to diversify the sources of the supply chain. In this acute period of the pandemic, we have seen how dependency on few sources has brought immeasurable difficulties. The economics of globalization as practiced in the past are now encountering the question of the different shapes of politics and power games. The world can not be safe if it is mortgaged to one source. The dependency created by one supply chain has caused anomalies in the national life of countries in a large swathe.

When we talk about diversifying the supply chain then India emerges as one very viable force with its huge resource base, large educated and skilled middle class, a propensity towards higher learning and research and product development, as it is a relatively open society, a democratic ethos which brings it much closer to West and Europe than the secretive bamboo walled society in the further East. Felicity in international dealings and the presence of the English language also helps India to come closer to a united Europe and particularly Greece. Athens could become the gateway for India to enter Europe, especially after the Brexit as London will no more be able to play a middleman between India and Europe.

Post pandemic world will have

to change its gears as the world changed after the second world war and a new era started with Marshal aid in Europe, the cold war, and rapid decolonization on a global level. This is an area where West, too, will have to think more openly and introspect as well. Mere competition in arms or in trade and commerce and technology may bring back the era of the cold war which may turn anytime into a mutually destructive war. The ideology of competition which was put on the pedestal of divinity has to accommodate the ideology of co-existence and cooperation. Pandemic has shown how total withdrawal of state and blind privatization, particularly in the realm of health care and education may be counter-productive. Similarly, the state machinery has to be empathetic and responsive to the demands of the common people. It needs in long run to return to the age-old Indian ideology of "Vasudhaiva Kutumbakam" i.e. the whole world is a family. This, perhaps, will be more effective than mere economic globalization, but globalization with an agenda for lasting peace, cooperation humane state, and empathetic and inclusive business. In such an arrangement the two old civilizations of India and Greece would fill the bill rather than the crass globalists and privatizers ruling the roost.

The tormented world with 'Chinese dream' and 'Make America great' can be tempered by the nondream adage of 'the whole world is a family' as a value system, rather than getting into an inferno of clashing dreams. •

# Greece - An Ideal place to Study for International Students

The cost of education in Greece will vary depending on

the subject and the level of study. On average, one is likely to pay somewhere in the range of 3,000 and 15,000 euros per year. Apart



However, the country did not attract, so far, the number of foreign students it rightly deserves, mainly due to the lack of educational

programs in English, which is now the most widely used international language. Foreign students would have to learn Greek, a rather diffi-

cult language, to be able to study at Greek universities.

This obstacle has begun to be removed in recent years as more and more Greek

universities started to offer study opportunities in English at Bachelor's and Master's degree levels for foreign students.

from the university fees, one has to calculate the cost of living, which is relatively low in Greece compared to many other European countries.

Non-EU students are required to obtain a student visa to become eligible to pursue their education in Greece. To obtain a student

visa, the candidate will have to submit the required documents to the Greek Consulate in his country. However, before the application, the student needs to make sure that he/she fulfills all requirements for admission to a Greek University / College. One must meet the academic requirements and have sufficient funds.

Foreign students who are admitted to Greek Universities get a residence permit in a short period from the Greek Immigration Authority and can apply for a room at university hostels or rent an apartment in the city of their study.

Overall, Greece provides a friendly and fertile environment for undergraduate and postgraduate studies. Those who study in Greece have further access to EU's study programs and can do internships or traineeships abroad.

The Study in Greece (SIG) program is the official project of Greece for the internationalization and extroversion of Greek

Higher Education Institutions that operates under the auspices of the Greek Ministries of Foreign Affairs, Education and Religious Affairs, Tourism, and Culture and Sports. The project's portal (https://studyingreece.edu.gr/) hosts and maintains all pertinent information related to the Greek

academic world. Presenting and promoting a wide variety of English (and other languages)-taught programs offered by the Greek Universities.

The Study in Greece program seeks to endorse Greece as a prime education hub for international students by inviting them to pursue their higher education in the country. ### Ayurveda and its global financial potential

World news is dominated by financial news and numbers regarding GDP, inflation rates, unemployment and salaries. In the Vedic tradition the concept of finance and wealth has a different meaning. To earn wealth, you must perform a duty or Dharma, as it is called in Sanskrit, helping society to live in a happier way.

The question regarding whether Ayurveda could have a financial potential in the modern world leads to the following query.

Could Ayurveda, which was developed thousands of years ago, help a society that is already served by state-of-the-art modern diagnostics and medical treatments?

To my mind, there are many areas that are still underserved by modern medicine and as an example I will mention two areas: namely, the stress problem and the management of chronic pain and, more specifically, the modern epidemic of migraine.

Let's look at some statistics from medical publications:

## 1) Stress impact in economy: Stress and health disparities. *American Psychological Association*, 2017

Stress related illness and injury are estimated to cost the United States more than \$300 billion per year, including costs related to stress-related accidents, absenteeism, employee turnover, diminished productivity, and direct medical, legal, and insurance costs (*American Institute of Stress*, 2013).

## 2) Health economics: *Lancet* **2021**, vol.397

The economic consequences of migraine emphasise the need for improved health policies that are informed by evidence. In Europe, financial costs attributed to migraine were estimated at €50 billion to €111 billion in 2011, of which direct costs accounted for 7% and indirect costs for 93%. In the USA, direct costs were estimated at US\$11 billion and indirect costs at \$12 billion in 2007.

#### 3) Drug Overdose Deaths:

"Centers for Disease Control and Prevention", *National Center for Injury Prevention and Control*, February 22, 2022

Nearly 841,000 people have died since 1999 from a drug overdose.1 In 2019, 70,630 drug overdose deaths occurred in the United States. The age-adjusted rate of overdose deaths increased by over 4% from 2018 (20.7 per 100,000) to 2019 (21.6 per 100,000).



- Opioids—mainly synthetic opioids (other than methadone)— are currently the main driver of drug overdose deaths.
- 72.9% of opioid-involved overdose deaths involve synthetic opioids.
- Opioids were involved in 49,860 overdose deaths in 2019 (70.6% of all drug overdose deaths).

P4 medicine: (predictive, preventative, personalized, participatory) that is considered the future of medicine, describes exactly what Ayurveda taught thousands of years ago.

Ayurveda describes the 3 basic energies that function in the body:
1) Vata or Kinetic energy, 2) Pitta or metabolic energy and 3) Kapha or homeostatic energy.

In this way it determines the possible energy imbalances before they occur, **predicting** potential disease



states.

It attempts to restore the correct balance of energies before a pathology takes place, therefore **preventing** diseases.

Personalized medicine is the definition of Ayurveda per se: disease is always described in relation to an individual and not as an abstract entity.

Finally, **participation** is a key factor in Ayurveda that asks the patient, or the healthy individual, to follow a diet and change his behaviour, so that they return to a healthy, balanced state.

In addition, if needed, Ayurveda describes a vast array of herbal preparations whose actions are supported by scientific research.

These can be used to help the healing process without causing side effects. Some of these are: Ashwagandha, Triphala, Guduchi, Vasaka etc.

The Ayurveda text of Susruta Samhita refers to a procedure called 'Agnikarma', in modern terms 'Thermal microcautery', that can be used in migraine and pain management with amazing results.

I hope and wish that this happens so we can achieve a holistic approach to modern health challenges.





#### Can a machine be conscious?





The purpose of this essay is to express an idea about how the title question can be approached and hopefully find a way towards potential answers. My aim here is to highlight the importance of clearly defining the different terms involved, as well as the implications that these definitions have in the follow up arguments. I briefly present some common theories on the underlying topic, along with my personal opinion based on my knowledge, research and understanding about consciousness and the future of AI, and by no means I believe it is the only answer to the question.

Admittedly, there is a general lack of consensus among scientists and philosophers about whether machines and specifically AI can become conscious. This is mainly due to the fact that there is no clear definition about what consciousness is, why it exists and which are its mechanisms (e.g. how can it be achieved) in humans, let alone machines. There are various attempts trying to define the term consciousness, including sentience, self-awareness, wakefulness, and opposing arguments about the potential that future AI may become conscious or not.

Integrated Information Theory (IIT) as presented by G. Tononi and colleagues [1, 2] introduces a link between the cause-effect power (involving some input, processing and output) and consciousness, where the latter is defined as broadly as subjective experience. Essentially it is a theory which can predict how conscious a physical system is, based on the level of integrated information  $(\Phi)$ , a metric expressing how much different parts of a system know about each other. It is believed that it has the potential to be applied in healthcare in order for doctors to understand whether seriously brain-injured patients (i.e. patients in coma) are in a vegetative state or not. In general, for IIT to be applied, a physical system requires memory, some kind of information processing and also it needs to be independent and integrated, so that the system as a whole is autonomous but their parts



are not. The authors believe that even if we manage to create AI machines which are perfect simulations of the human brain, they will not have subjective experience [3], since mimicking the behaviour of a conscious being is very different from actually being a center of subjective experience.

Professor of physics Max Tegmark [4], starting from the fundamental truth of physics that everything around us is quarks and electrons arranged in a certain way, asks the question, which particle arrangements are conscious and which are not. He argues that probably consciousness is an "emerging" phenomenon meaning that it has properties above and beyond their particles. So, the same way as other "emerging" phenomena, the properties of consciousness are independent of its physical substrate. Opposing to researchers who argue that consciousness cannot be studied scientifically, he explains that with a theory such as the IIT (mentioned above), we can test which systems are conscious and which are not, and as a result this is by definition a scientific methodology. On the other hand he leaves space for harder questions such as "How do physical properties determine qualia [5]?" or "Why is anything conscious?" for which there is not a known scientific approach. He continues stating that if consciousness is the way information feels when it is processed, then what is important is the structure of information, and not the matter where information processing takes place. This definition of subjective experience,  $\rightarrow$ 

leaves open the possibility that some future AI could be conscious even if they are just a piece of software.

It is a fact that science and technology have made great progress towards understanding how the brain processes information. Intelligent machines such as Alpha Go and self-driving cars have already proven their ability to perform complex tasks (conquering the game of Go and driving a car respectively) surpassing human level performance and it is believed that in the not so long future, machines will be superior to humans in almost all the tasks that involve computations and processing of information. But, what if consciousness does not have to do with memory and information processing at all? Since we as humans agree that we do not understand what exactly is consciousness, this might also be a possibility worth considering. If we manage to

This is an interesting differentiation because in western medicine there is no clear distinction between wakefulness and consciousness, as seen in the case of anesthesia, or patients in coma as mentioned before [8]. Jagrat corresponds to the perception of entities different from the perceiving subject which means that the focus is outwards. The second stage is called swapna (dream state) and it is far more vivid than the previous state in the sense that it is more profound in terms of experience. By closing the eyes one can detach from the outside world and look into the inside world. The perception focuses on mind-generated objects different from the subject (the focus here is inwards). The third stage is called sushupti which means deep sleep. This is a stage where no images, no words, no thoughts and essentially no information exists in one's mind. There is no difference in perception between object and subject and it is often parallelised as the separation of oneself from the mind. Finally, it is turiya or the fourth, a state where no memory of any kind is involved (here the term memory is used not only for what a person remembers, but also includes genetic memory, evolutionary memory, elemental memory and all the different aspects of memory that have been acquired during the process of evolution). This state is what in the yogic philosophy is considered as pure consciousness. A state of being

beyond memory.

All the above describe experiences that have been witnessed as such by many people who have practiced meditation. Although some might argue that this is beyond science I believe that, in our attempt as human beings to understand what subjective experience exactly is, it is smart enough to at least try to learn more about these experiences themselves. At the end of the day, it is the only evidence (scientific or not) that we have about how it feels to be a human.

Humans admittedly are the most complicated and sophisticated creatures on earth. That is the reason why we are at the top of evolution. If we manage to create a "thing" that has the capabilities and sophistication

> mechanisms we have, then it might be possible that this "thing" can access the dimension of consciousness. However, even the most impressive today's intelligent machines are designed to mimic the human brain and as a result show no evidence towards this direction. This is simply because we do not know exactly how the brain works so that we can reverse engineer it.

Consciousness is one of the biggest mysteries of life. Yet humans are the only creatures on earth that can access this dimension of life to such a wide degree. So, it is worth trying to experience it and feel how it is to be a human, and then find ways to define it and study it. After all, in the near future Artificial Intelligence will by far exceed the limits of human intelligence in almost all the tasks, so consciousness might be the only differentiation left between humans and machines. As Max Tegmark suggests, maybe it is time to rebrand ourselves as Homo sentiens.





In our experience, the key to concluding business is to know exactly who you want to meet and why. This requires research on your part as no one knows your business better than you. Following a preliminary study and initial contact, the parties must meet to see each other and decide how business can be done. A good Indian friend,



after his thorough research, came to Athens to meet (only) one specific food producer and for one specific feta cheese. After meeting, they signed a contract. Obviously, trade fairs assist but still at the end of the day, travels and direct contacts must be made.

This means besides researching the market, eventually one has to get on an airplane, visit potential collaborators and partners, possibly hire legal counsel, marketing consultants, and whatever else is required according to the nature of his business.

Within this spirit, the Hellenic Association of Travel and Tourist Agencies (HATTA) invited and extended full hospitality to 70 members of the Out-

bound Tour Operators Association of India (OTOAI) who came to broaden their professional collaboration and accommodate a strong demand of Indians for trips to Greece. The invitation has become a logical outcome since the number of Indian tourists keeps increasing over the last few years.

Likewise, when we did business with other countries, we researched possibilities beforehand and closed

meetings with specific companies that met our desired profile. In turn, we provided them in advance with as much relevant information as possible. We needed to see their operation, their offices, how they managed their people, etc. to determine if we should proceed with them in signing a contract or not.

# Painting exhibition for the 200<sup>th</sup> anniversary of the Greek Revolution in New Delhi, Nov. 21-27, 2021

Full of pride I became arrogant, One day, while I was standing on a small wall, suddenly flying from afar, a straw fell on my eye.



His literature-service earned him considerable fame. He had been conferred the title of Vidyavachaspati. He died in 1947 at Azamgarh.
